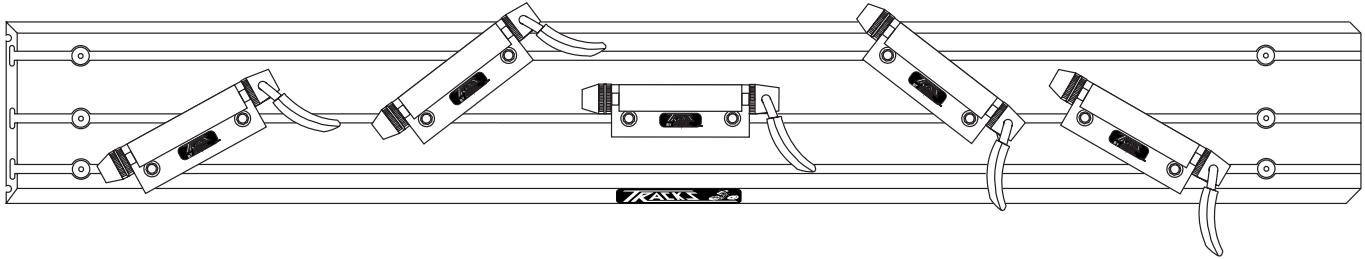
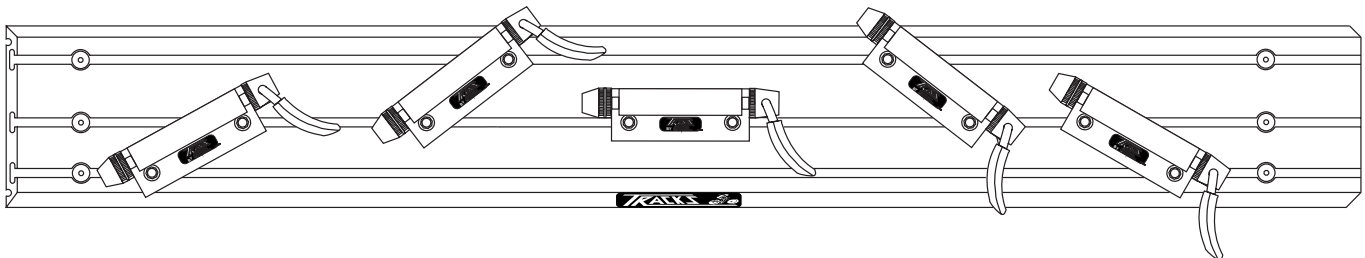


Please READ and FOLLOW all instructions carefully.



The Triple Track carrier was designed to carry bicycles inside of vans and sport utility vehicles. Once you have made adequate space inside of your vehicle, place Triple Track in the vehicle. The carrier comes equipped with rubber pads on the bottom to prevent it from sliding around in the vehicle. It is possible to permanently secure carrier by utilizing the holes in the center track. Depending on the number of bikes that you are transporting, it may be necessary to stagger your Traps. The above illustration shows the different positions that you can mount the Traps in.

- When using carrier in a truck that doesn't have a tail gate, make sure to secure either carrier or bikes to the vehicle.
